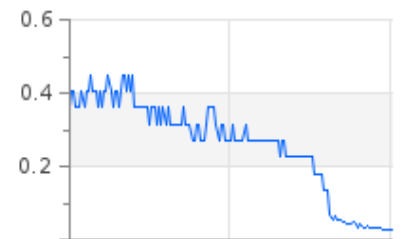
Shares of Progressive Planet Inc were at C\$0.05 on Tuesday.
