## Great Boulder Resources appoints Andrew Paterson as managing director

Great Boulder chairman Greg Hall, who will continue to act as interim chief executive officer until June 24, welcomed Paterson to the team and looks forward to working with him.

Last month the company intersected strong nickel-copper-PGE anomalism, highlighting the growing potential of the Winchester JV in WA's Yamarna region.

Great Boulder's aircore drilling program extended known anomalism to more than 25 kilometres and this includes grades of up to 1.1% copper, 0.7% nickel and 0.04% cobalt.

This has resulted in the company meeting the first milestone in the Winchester JV with Ausgold Ltd (ASX:AUC), thereby earning 51% of the project.
