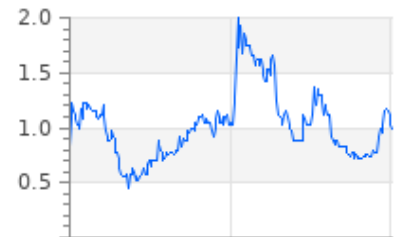
Highlights from shallow holes include gold grades up to 7.8 grams per tonne in one section.
