## Gold Resource talks ramp-up of potential ounces at Nevada mine with exploration drilling


Gold Resource Corporation (NYSEAMERICAN:GORO) has added potential ounces to its Isabella Pearl mine in Nevada with further exploration drilling.

Reid says 27 exploration holes had been sunk into the deposit's Pearl area within and outside the current pit-shell. Reid says the miner is now targeting north of the deposit, the goal being to add a full fifth year to its mine life.
