Newgioco Group subsidiary Odissea has passed First Stage of ISO-27001 Certification Standard

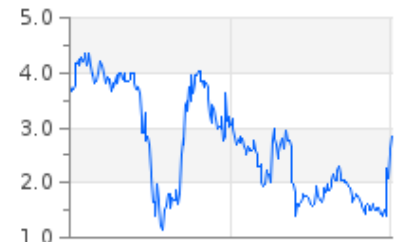
